	Group) to enable highlighting of status of action items within their directorates or			
	agencies.

	 CO RFS confirmed that all the data from various inputs is being 			
	captured in one map in order to better understand if mitigation action is			
	required via either Government agencies or in partnership with relevant			
	Rural Landholders. Additionally, the annual meetings / planning forums			
	are being better structured in order to ensure that all stakeholders are			
	involved and clearly understand what actions are being undertaken			

	 across the Territory. This is intended to have all understand what the situation is and what will be the best approach to ensure risk reduction across the Territory. Item 63 – what analysis and work has been undertaken within this item in relation to the 2020 events. RFS and PCS Fire Unit have commenced reviewing the data available, this includes undertaking an evaluation of decisions made during the Orroral Fire with RFS Brigade Captains (inlcuidng PCS). Tony Bartlett offered to provide a report written with respect to a review undertaken previously in Gippsland (1980''s). Commissioner ESA invited Tony Bartlett and BFC members to attend the evaluation meetings. Item 87 – Has it been confirmed that an edge road is included in the final development plans within Canberra, particularly in the Denman / Prospect area. 4.	ESA Operational Review – presentation by Synergy Synergy provide a presentation with regards to the ESA Operational Review undertaken			
	in response to the 2020 emergency events. This presentation looked at the methodology and approach used for the review and the key findings.			
	 Council sort clarification of the following: Clarification regarding RFS integration into the IMT. Synergy and ESA Commissioner clarified that this was related to the communications issues between the IMT and the coalface that gave a perception of lack of integration and understanding of the whole picture from strategic to tactical level. There was discussion regarding how this was addressed during the events, improvements made during the events and future intent for addressing to reduce the likelihood to happen in the future. 			
	 What involvement did PCS / EPSDD have in the review? Although interviews with PCS staff was not completed, their submissions to the Royal Commission and input through the AAR's undertaken post the events were all considered. 			

	Tony Bartlett provided a summary of the presentation and his report. Discussion was held around the fact that the tool is a work in progress and how this is expected to evolve over the next two to three years. The Council expressed their appreciation in receiving the briefing. It was raised that the council would like to continue to receive updates on the progress of these systems. In particular, they would like to see how this will be linked to BOP and a whole of Territory approach. It was noted that was intended to include information available from Commonwealth and non-government land managers. 7.	Update of 2019-20 Reviews – presentation by Commissioner ESA			
	Commissioner ESA provided an update of the action being undertaken by ESA in response to the various reviews (internal, ACT, interstate and National). The Council was advised that as the ACT Government response to the Royal Commission was not able to be included as it was still to be finalised. It was noted that this presentation was specific to ESA and recommendations that were within ESA remit. EPSDD confirmed that they also are tracking recommendations across reviews. The tracking system is designed not only to track the actions being undertaken against individual recommendation but also link to future capability requirements and forward budget / business cases to support this. It was confirmed that the dashboard and supporting documents would be available for Council members to observe the progress of the action items. This will also be included in the annual preparedness briefing to Council for preparedness, with identification of critical actions and their status.			
	 Council sort clarification on the following: Is there overlap across recommendations between the differing reviews and report. There are a number of overlaps and these will be identified within the tracker. Are there linkages to the SBMP. It is expected to be able to identify this as the Royal Commission, in particular, are finalised. These will be identified within the tracker as 			

	 well for ESA. Has the SBMP Governance Committee given thought to the priority of actions / recommendations It was noted that given the nature of SBMP that some recommendations / actions cannot start until set periods within the five years of the SBMP. It was noted that the SBMP would commence being reviewed and analysis undertaken for the development of SBMP 5 with current consideration being that it is due for a deep dive a rewrite, not just a refresh.
