	Council received a presentation from Professor Mark Howden - Director of the Institute for Climate, Energy & Disaster Solutions with regards to Climate change - understanding risks within ACT and Surrounds. Council discussed a number of items raised in the presentation relating to high risk weather, intensified and prolonged bushfire and storm seasons, and what this means for the ACT and the combat agencies supporting the response effort to any natural

	<p>Council received a presentation from Sam Engele – Coordinator General for Climate Action with regards to Climate change and work being undertaken within ACT Government.</p> <p>Council discussed</p> <ul style="list-style-type: none"> • Dr Bartlett raised that the proposed report focuses only on risks internal to the ACT Government and should look deeper on impacts, including built assets from a local community perspective. • Important to note - the Justice and Community Safety Directorate (JACS) is doing a Territory Wide risk assessment separately to the Climate Risk Assessment • Mr Kendall asked what would be next following this assessment and what will the ACT Government funding process look like <p>Mr Engele explained that a Business Case will be submitted to Cabinet promoting a systematic approach focusing on the long-term and projected risks. This rain will impact the ability to conduct burns during the Autumn season.
